EQUINE RULES AND REGULATIONS

1. General

- a. Barn hours are Monday -Saturday 8 AM 8 PM and Sunday 8 AM 5 PM.
- b. No smoking, vaping, drug or alcohol use.
- c. The speed limit on the property is 10 MPH for the safety of horses, riders and children.
- d. All trash must be disposed of in designated areas only.
- e. Animals of any kind brought to the facility must observe all regulations of the State of Florida Animal Health Division, and for equines must include a valid proof of a Negative Coggins Test (within prior 12 months).
- f. All animals must be treated in a humane manner in accordance with state humane society guidelines. If any Rider or Guest is found treating any animal in an inhumane manner, the Rider or Guest will be removed from the premises immediately and be subject to potential liability.
- 2. Safety
 - a. It is the responsibility of parents/ guardians to supervise their children at all times when on the property.
 - b. No jumping unless part of lesson with a trainer present.
 - c. Appropriate, closed-toe footwear is highly recommended for everyone near the horses or stable.
 - d. Horses must be ridden in a safe and controlled manner at all times
 - e. Any accidents involving injuries must be reported to stable owners and trainers immediately.
 - f. Only tie horses to appropriate and designated locations.
 - g. Do not leave horse unattended in any area.
- 3. Personal Riding Equipment
 - a. All Riders must wear an ASTM/ SEI approved helmet at all times when mounted on a horse. No exceptions.
 - b. Long pants and riding boots with a heel are recommended for riding.
- 4. Pets
 - a. Rider pets or personal animals other than horses are expressly prohibited. Riders or Guests are however permitted to bring emotional service animals as permitted under the Americans with Disabilities Act.
 - i. Service animals are not permitted in or around the riding arena or in the stable area.
- 5. Public Conduct
 - a. Everyone is expected to behave in a manner that promotes good order and discipline.
 - b. Anyone who behaves in a manner that is contrary, to include disorderly conduct, foul or abusive language, cruelty and/or intoxication, will be subject to loss of privileges and/or termination of use of facilities.
- 6. Tack and Feed Rooms
 - a. Tack and feed rooms are for the storage of horse feed and supplies and horse-related equipment only.
 - b. No dangerous, inappropriate or flammable materials such as paint or gasoline will be stored in the tack and feed rooms.
- 7. Equipment

- a. All stable equipment will be returned to their proper place in a clean and serviceable condition. Broken or damaged items will be set aside and called to the attention of stable owners/ trainers.
- 8. Saddle and Grooming Areas
 - a. Manure will be removed, and holes caused by horses digging will be filled by the person responsible.
 - b. The wash rack and cross ties will be kept clean of manure and debris, shedded hair, and hoof cleanings.
- 9. Turnouts
 - a. Riding in any turnout area is strictly prohibited.
 - b. It is recommended that halters are removed from all horses prior to turn out.
- 10. Training
 - a. Only trainers approved by the stable owners and complying with the Insurance and Liability rules below may offer lessons to the general public.
 - b. All riders are required to be in a lesson program unless specific, written arrangements have been made prior.
- 11. Insurance and Liability
 - a. All Riders or persons handling a horse must sign a release before riding and/or boarding any horses in any way. Boarders are responsible for having Guests sign releases which are available in the office.
 - b. Guests must be in the presence of adult boarder.
 - c. Prior to riding or handling of any kind, Guest must sign Release of Liability form.
 - d. All trainers must provide proof of insurance for a minimum amount of \$1,000,000, listing the Razorback Equestrian Center on the policy. This must be provided one week prior to any lessons given. It is the responsibility of the trainer to keep all insurance policies current and updated and provide barn owners with notification of such.
 - e. Organizers of any events must have prior approval from stable owners.
